## FEE SCHEDULE –2022

Additional fees may apply for overseas students and dependents of temporary visa holders.

Entry fees			
Enrolment confirmation fee	A non-refundable enrolment confirmation fee of \$365 per student is payable upon acceptance of the offer of a place at the school.		
Enrolment Deposit	<p>Upon confirmation of enrolment, an Enrolment Deposit of \$1,350 is payable. This deposit is payable per student and is non-transferable to a later entry year should enrolment not proceed with the initial requested year level. This deposit will then be provided back to families as a credit to their last fee invoice in the last year of their enrolment.</p> <p><b>NOTIFICATION OF INTENTION TO LEAVE</b> In accordance with the Enrolment Agreement, at least one full term's notice, in writing, must be given of a student's intention to leave the school. Failure to provide such notice will result in a forfeit of the enrolment deposit paid upon acceptance of the enrolment. A 'term' is defined as the dates specified in the Annual School Calendar, e.g. notification of intention to leave at the end of Term 4 would be required prior to the date of commencement of Term 4.</p>

Tuition fees (per student)	\$1,350	\$5,400	Includes all compulsory activities specified in the school curriculum, subject materials, text books, musical instruments, sports days and excursions as specified in the curriculum but excludes any extra-curricular items.
<ul style="list-style-type: none"> <li>A fee of \$50 will be added to quarterly tuition fees not paid in full before the start of the first teaching day each term.</li> </ul>			
Additional charges			
<p><b>Students</b> will be charged an annual <b>device levy</b> of \$75, which provides each student access to a 1:1 school managed device. The annual levy covers the associated costs of a 1:1 device program such as the purchase of the device, maintenance, software and insurances. Please note there is an excess of \$150 for any claim made for malicious or accidental damage.</p>			
Other items			
Late payments	Students with any fees or levies outstanding at the end of term are not eligible for admission to the next term. Any family dealing with serious financial hardship is invited to proactively discuss this matter with the school's Principal or Business Manager on a confidential basis.		
Student transfers	The school must receive written notice at least one term in advance if a family decides to transfer a student to another school. This notice helps the school to manage vacancies. A full term's fees are payable in lieu of the school receiving this notice.
